## Real Estate Pre-licensing Course

Thank you for your interest in the AlaskaRealEstateSchool.com. Our class time will consist of 40 hours of instruction, correspondence and classroom, to prepare you to take the Alaska state real estate examination. We will cover at a minimum:

Real Estate Brokerage and Agency	4 hours
Real Property and the Law	4 hours
Real Estate Ownership	4 hours
Conveyances and Recording	4 hours
Contracts	8 hours
Financing Instruments	6 hours
Fair Housing	4 hours
Alaska Real Estate Licensing Law	6 hours
Real Estate Math and Local Real Estate Practices	as needed

The course will be 40 hours, 20 hours of correspondence with open book chapter tests to be completed before the class portion and 20 hours in class. Each classroom hour of instruction will consist of 50 minutes of classroom time. Students will be required to sign in at the beginning of the class and sign out upon completion to receive credit for the class. If a student misses 15 minutes of class time, no credit will be given for that module and it must be made up to graduate per state regulations.

Class times and dates will be on the attached schedule.

If you have an emergency and cannot attend class, call (907)337-9663(Anchorage) and inform the instructor as soon as possible. Missed classes may be made up during the next scheduled class.

The testing schedule is as follows: The tests are given throughout Alaska. To register for the test, call Pearson VUE Candidate Care Center at 1-800-274-5992, Monday through Friday from 4:00 a.m. to 7:00 p.m. Alaska time or 4:00 a.m. to 11:00 a.m. on Saturday or 6:00 a.m. to 1:00 p.m. on Sunday. You must make an appointment 3 days or more prior to the Saturday testing date. **Walk-in testing is not available.** The testing fee of \$100.00 must be paid the day registering for the exam. For more information see the pamphlet printed by the State of Alaska "Real Estate Candidate Handbook."

**Upon full payment of tuition you may receive the course materials early if you wish. Call ahead so we can set the manual out for pickup.**
